II. Development of the China Market

1. Income levels

According to data from the National Bureau of Statistics of China, the per capita disposable income of Chinese residents in 2023 was RMB 39,218, a nominal increase of 6.3% compared to 2022. After adjusting for price factors, the actual increase was 6.1%. The per capita disposable income of urban residents was RMB 51,821, a nominal increase of 5.1% compared to the previous year. After deducting price factors, the actual growth was 4.8%. For rural residents, the per capita disposable income was RMB 21,691, a nominal increase of 7.7% compared to the previous year. After deducting price factors, the actual growth was 7.6%. The national median per capita disposable income was RMB 33,036, a nominal growth of 5.3% compared to the previous year.

2. Consumer profiling

With the pursuit of healthy life and the appreciation of traditional culture, new teas combining traditional culture with modern trend elements and are warmly embraced by consumers. New teas have become a lifestyle habit for young people. The consumers of new tea drinks are mainly young people, who have a strong demand for fashion, personalization, and health, and are more receptive to tea drinks. At the same time, the new tea brand focuses on building a young and fashionable brand image, and has attracted the attention and participation of young consumers through social media and offline events, further expanding their consumer base. Females account for nearly 70% of tea consumers, and the post-90s and post-2000s generation have become the main consumers of new teas, accounting for approximately 75% of the market. According to the census data of China, the total population of the post-90s and post-2000s generations exceeds 330 million. The post-90s generation is entering a golden period of career development, while the first batch of post-2000s has already entered society. Among the new tea consumers, 44.3% have an income of RMB 5,001 to 10,000, and 29.9% of them have an income of RMB 10,001 to 15,000. They are willing to spend, generally value quality and service, are intrigued by new things, and pursue personalization, diverse, and experiential consumption. At the same time, with the upgrading of consumption, new tea drinks are also iterated continuously, developing in a healthier, more natural, and safer path. New tea brands have launched some drinks suitable for children and middle-aged and elderly people, further expanding the consumer base. The vast consumer base brings broad development space for the new tea beverage market.

3. Development opportunities for the food and beverage industry:

2023 was a year marked by the waning influence of the pandemic and the restoration of economic order, as well as a year of recovery for the catering industry. Despite the ups and downs throughout the year, the return to the normal rhythms of life and the pursuit of happiness were gradually coming back into people's focus. According to data released by the National Bureau of Statistics of China, the catering revenue in China was RMB 5.289 trillion in 2023, a year-on-year increase of 20.4%. Under the background of the gradual

recovery of the catering industry and the dual boost from cultural confidence and supply chain capacity overflow, the trend of going global became "phenomenal" in 2023.

The gradually improving macroeconomic environment is the foundation for confidence in future catering development. With consumer willingness steadily rising to historic highs, the catering consumption continues to recover rapidly, driving an increasingly stronger domestic demand. The continuous increase in the chain restaurant penetration rate indicates promising prospects. Looking ahead, enterprises are actively adjusting their operational strategies to embrace new development opportunities.

4. Competitive Landscape:

After enduring three years of pandemic induced hardships, the consumer market witnessed a comprehensive recovery in 2023. However, the slogan of "revenge consumption" did not seem to manifest within the tea beverage market. A trend towards rational and healthy consumption has emerged, promoting increasing doubt among consumer about questionable characteristics such as high sugar, high fat, and high trans fatty acids in the tea beverages, which has compelled the market to introduce new tea drinks.

In 2023, the new tea beverage industry experienced a year of "involution", including aspects such as "pricing", "product", "scenario", "experience", "marketing", "listing", and "overseas expansion", etc. However, it is precisely because of this internal competition that the industry has accelerated its standardization and normalization, promoting the mutual progress of consumption and the market.

In 2024, it is foreseeable that new tea beverage brands will continue to fiercely compete in various directions such as "second-tier", "10 thousand store plans", "sinking", and "overseas expansion". However, in these tracks, it is destined that the disruptors will advance and the conservatives will be eliminated. The new tea beverage market will also accelerate the survival of the fittest and enter a new round of reshuffling.

III. Summary of 2024 Operational Plan

1. Business guidelines

The Company is a full-service provider of raw materials for new tea beverages. The Company mainly engages in the R&D, production, and sales of juice products, fruit pulps, and textured granule products, playing an important role in the supply chain of the new tea beverage industry. The Company has always been committed to producing natural, healthy, safe, and delicious products, and is dedicated to the development and upgrading of high-quality products. The Company continuously meets the personalized needs of new tea beverage companies and provides customized products and full-process services to customers.

2. Sales target and the basis

In 2023, China's full-year GDP exceeded RMB 126 trillion, an increase of 5.2% over

the previous year. The economic growth rate is higher than the global economic growth rate of about 3%, ranking first among the world's major economies, contributing more than 30% to world economic growth, being the largest engine of world economic growth. Goldman Sachs predicts that China's GDP growth rate in 2024 is expected to reach 4.8%, and consumption and investment will become the engines of economic growth.

According to the data of the "2023 New Tea Beverage Research Report" published by the China Chain Store & Franchise Association, in the first half of 2023, the "new tea beverages" consumer market rebounded strongly in the first quarter, grew steadily in the second quarter, and performed well in the summer. The annual new tea beverage consumer market scale is expected to reach 149.8 billion, recovering the 3-year compound growth rate of nearly 20%. By 2025, the domestic consumer market is expected to further expand to NTD 201.5 billion. In terms of the number of stores, as of August 31, 2023, there were approximately 515 thousand new tea beverage stores in operation, compared to 378 thousand at the end of 2020, representing a growth of over 36%. Judging from the proportion of beverage stores included in Meituan, Dianping and Meituan's takeaway platform, in June 2023, new tea stores accounted for 57.7% of the total number of beverage stores, a decrease of 2.2% from the end of 2022.

The new tea beverage industry has a high level of standardization and strong reproducibility, and is the category in the catering industry with the highest chain store rate. According to the forecast of the CUBA Research Institute, the chain store rate of China's new tea beverage industry will reach 63.89% in 2023. Judging from the changes in the number of new tea brand stores of different scales, the number of small-scale brand stores has continued to decrease in the past three years. The growth in the number of stores of large-scale chain brands in 2023 is accelerated, and the "Ten Thousand Stores Plan" has become an inevitable goal.

As the macroeconomic recovery in China has restored public confidence, the willingness to consume gradually increased, and the new tea beverages will usher in stable growth. In 2024, based on the current status of the industry and the Company's plans, the growth target in line with the overall interest of the Company has been formulated to maintain the continuous growth of the Company's performance.

3. Policy and market factors

In 2024, the international environment will continue to be extremely complex, due to ongoing conflicts of Russia-Ukraine and Palestine-Israel. The rapid development of artificial intelligence has triggered ethical disputes, while the increasingly severe challenges of climate change demand collective action. Multiple global dynamics are evolving simultaneously, accelerating the evolution of international order. Many areas are still facing significant uncertainties. The economic development in China is still faced with the triple pressure of demand contraction, supply shocks and weakening expectations. This is why China's economic work in 2024 will still be based on "adhering to the general principle of seeking progress while maintaining stability", emphasizing "consolidation and

enhancement of the positive trend of economic recovery, and continuous promotion of economic qualitative and efficient improvements as well as reasonable growth in quantity." Currently, China is at a crucial stage of economic recovery and industrial transformation and upgrading. Under the strong leadership of the central government of China, local governments are implementing high-quality decision-making arrangements to promote sustained and healthy economic development.

The middle-income group in China continues to expand, and there is great potential for people's needs for clothing, food, shelter, transportation, and cultural consumption. As consumption upgrades and consumer confidence increases, the consumption attributes of new tea beverages in 2024 will allow more people to consume, dare to consume, and willing to consume. With the implementation of various policies, new impetus will be injected into the development of the Chinese economy. The new tea beverages industry will flourish as a pioneering force in the catering industry.

IV. Important Strategies for 2024

1. Production strategy:

The Company continues to deepen the lean production management concept, optimizes the warehouse management (WMS) system and adds the transportation management (TMS) system based on the original office system. We continue to improve and deploy automated and intelligent production lines to improve production efficiency and create a smart chemical plant. In order to meet the diversified needs of customers, the Company not only realizes the production requirements of customers in multiple varieties, small batches, multiple batches, and various specifications, but also strategically position ourselves to address requirements for large-scale production, large batch orders, and continuous production. The Company's WMS system, SAP system, and TMS system are connected to achieve product traceability throughout the process of production, warehousing, and transportation, and provide high-quality and efficient supply chain services for new tea customers. Currently, the Company has four factories, located in Kunshan Jiangsu, Zhaoqing Guangdong, Tianjin Binhai, and Base Guangxi. The Kunshan, Guangdong, and Tianjin production bases serve customers in their respective regions, allowing for shorter transportation distances. This not only improves the efficiency of raw materials distribution to customers but also effectively reduces transportation costs. The Company's three production facilities have a unified standard production process, which ensures stable product quality. This allows the Company to serve customers located throughout the country through its nationwide sales network. This provides customers with strong supply chain support so they can expand their business throughout the country while maintaining stable product quality. The upstream raw material factory in Guangxi supplies the advantageous raw materials to the factories in Kunshan, Guangdong, and Tianjin to ensure the quality and price of raw materials, while also providing customized products for some of the new tea customers.

2. Sales strategy:

The Company's current sales model primarily focuses on direct sales, with some coverage in distribution channels. Through years of strategic planning, the Company has established a relatively complete marketing network system with efficient and high-quality sales channels, and maintains close cooperative relationships with various channels. As the new tea brand becomes a chain store, the proportion of direct selling customers has exceeded 70%. For direct selling customers, the Company has established dedicated customer service teams at all three factories. These teams are capable of providing exclusive formulas and packaging based on customer requirements, ensuring product differentiation. They also offer customized sales and distribution services to guarantee the stability of product supply quality and maintain the order of customer chain operations, which helps establish longterm partnerships built on mutual trust. For distribution customers, the Company has established a comprehensive network of distributors nationwide. In the context of competition in mature markets, the Company regularly provides market information and new product training to distributors. This enables distributors to quickly introduce the Company's new products to regional markets, expanding the Company's product visibility and influence.

Customer development aspect: The Company will segment the market into different customer groups and position them according to their needs and characteristics. For example, catering enterprises, coffee system, tea beverage chain, etc., design and customize sales plans for different customer groups, and provide targeted products and services.

Market research aspect: Understand the development trends, demand characteristics, and the competitive landscape of the tea beverage market, obtain market information through methods such as market research, product studies, and data analysis; understand consumer demand and preferences for tea raw materials, and identify market opportunities and potential customers.

Pricing strategy aspect: Formulate a reasonable pricing strategy based on product costs, market demand, and competitive conditions and develop a reasonable pricing strategy that considers the balance between price and value; strive to achieve customer satisfaction while maintaining profitability for the Company. Meanwhile, according to the level, scale and positioning of customers, we will offer specific pricing and contract binding to attract and retain customers and increase our sales share.

3. R&D strategy:

The Company has a specialized R&D department that has established a comprehensive R&D system. The R&D department has a solid understanding of the fresh and healthy development trends in the beverage market and focuses on the development of nutritious and healthy products. The R&D Office is equipped with advanced experimental equipment that can conduct basic research, overcome technical difficulties, reserve innovative technologies, optimize production processes and technologies, and improve product quality and diversification. This setup facilitates the efficient development and mass production of new products, driving market trends. The Company can complete the entire process from

R&D creativity or responding customer demand proposal, to sample production, cost accounting, beverage application testing, rapid response testing in the pilot workshop, and marketing trial within one month. The Company's R&D team regularly visits the market and maintains close contact with customers to deepen customer cooperation and provide comprehensive solutions. At the same time, the Company can also develop new products in collaboration with various types of customers, providing tailored customized formulas to enable customers to have differentiated and competitive products in the channel.

Over the years of research and innovation, the Company has developed a robust product line, producing close to 2,000 different specifications and categories of products each year. Regarding product quality, the Company offers products with various amounts of fruit juice or pulp. In terms of taste, the Company offers popular flavors such as strawberry, mango, passion fruit, lemon, grape, and peach, as well as less common ones such as Chinese berry, mulberry, Orahmandarin, Hawthorn Berry, and Chaenomeles speciosa. The Company also offers a variety of fruit-flavored complex tastes. In the direction of beverage upgrades, real tea, milk, fruit, sugar, and zero additives have become selling points for major brands in marketing, and they have also become preferred choice for consumers when buying beverages. At the same time, the texture granules have played a crucial role in promoting the popularity of new tea additives. The Company has upgraded its texture granules products and launched the Red Bean Pearls and shaped crystal balls. With the continuous expansion of new tea beverage channels, the Company has launched new tea beverage products suitable for new retail channels, such as Mango Pomelo Sago, Chinese berry sago, flavored lemon tea, and lime juice, with advanced technology and food safety management. The Company's extensive and comprehensive product line can meet the diverse needs of the market and provide customers with diversified choices.

In response to the needs of the rapid development of the new tea beverage market, the Company newly deployed R&D centers for key customers this year. The marketing department's proposals, customer needs and R&D implementation are connected to meet customer product needs accurately and quickly develop new products and new flavors to cater for changing consumer needs.

4. Environmental protection strategy

In response to national requirements for ecological protection boundaries, environmental quality standards, resource utilization limits, and goals for ecological zoning control to promote sustainable economic and social development, the Company has installed new sewage treatment equipment and systems to enhance sewage treatment capacity. Industrial wastewater generated during the production process is treated at the Company's own wastewater treatment plant, which ensures that the COD content of discharged water is less than 50% of local discharge standards set by the country. Additionally, the treated water is used for landscaping irrigation within the factory premises and solid waste cleaning, thereby reducing emissions.

The Company continues to improve its processes and upgrade its equipment annually,

reducing the amount of solid waste generated during production. Solar energy is used to power outdoor lights, and it is increasingly used in newly built companies. Different energy-saving and emission-reduction measures are formulated according to the geographical location and temperature differences of different factories, in order to reduce energy consumption and reduce pollution to the environment.

5. Quality strategy

The Company's products are raw materials for beverages that have a direct impact on consumers' health. Food safety has always been a top priority for the Company, and thus the Company has obtained certifications for ISO 9001 quality control system, ISO 22000 food safety management system, FSSC 22000 food safety system, HACCP management system, and ISO 14001 environmental management system. The Company has established a food safety management system that includes supplier evaluation, inbound inspection, raw material usage, production process monitoring, and product release inspection to guarantee product quality and safety. Every step is meticulously executed according to relevant quality standards to maintain quality control throughout the procurement, production, and sales processes. The Company's quality control system is effective and product quality is stable.

V. Affected by the economic environment, external competitive environment, and regulatory environments

- 1. Influence of the economic environment
- In 2023, China's economy withstood external pressures and internal difficulties, with an overall recovery in economic development, and major targets were successfully achieved. Whether it was a horizontal comparison with major global economies, or a vertical comparison with China in the past few years, China's economic "report card" in 2023 was indeed hard-won. Entering 2024, the uncertainties of the international situation, including trade protectionism, technological blockade and geopolitical tension will affect the global supply chain system, and the global economy will fall into a period of slow growth for the long-term. These factors will bring greater pressure to the economy in China.
- ② Climate changes and environmental protection pose global challenges in 2024. The uncertainties in geopolitics and extreme weather conditions leads to fluctuations in energy, food, and commodity prices. Inflation will continue to drive up consumer prices, resulting in increased consumer spending for residents. However, with no significant growth in income, non-essential expenses may face reductions.
- The year 2024 marks the 75th anniversary since the founding of the People's Republic of China and is a critical year for the implementation of the "14th Five-Year Plan". China government's economic work conference has made important arrangements for economic work in 2024, emphasizing the principles of seeking progress while maintaining stability, promoting stability through progress, and addressing challenges in a proactive manner Through innovation in science and technology, we aim to lead

the construction of a modernized industrial system. We will strengthen policy coordination to ensure that macroeconomic policies are aligned and synergized, accelerating the establishment of a unified national market and achieving a higher level of supply-demand balance. We will further expand high-level and opening-up to the outside world, promote urban-rural integration and regional coordinated development, effectively safeguard and improve people's lives, ensure stable employment for key groups, and vigorously promote the sustained improvement of the employment situation. By promoting more abundant and higher-quality employment opportunities, we aim to increase the income of workers and ensure that the people truly feel the tangible benefits. With the support of these favorable policies, new tea is ushering in a new growth point with its social attributes and the emotional needs of young people.

④ On the positive side, there are many opportunities for China's economic development. First, China has the super large-scale market with the most potential in the world. As social expectations gradually improve, high savings will gradually shift to consumption and investment. Second, macroeconomic policies will continue to provide support for economic recovery. This year, China will continue to issue RMB 1 trillion government bonds, and the effects of policies such as cutting reserve requirement ratio, reduce taxes, and fee reductions will continue to be released in Q2 and Q3. Additionally, new measures will be introduced, with incremental and stock policies working together to effectively promote economic recovery. Third is to increase efforts to attract foreign investment and continue to optimize the business environment. Last but not least, the new round of global technological revolution and industrial reform contains new opportunities. Technology breakthroughs in big data, artificial intelligence, new energy, quantum technology, bio-manufacturing and other fields are accelerating, driving faster transformation in production and consumption. Such developments will foster industrial changes, providing a broader stage for economic development in China.

2. Influence of the competitive environment

The impact of China's external competitive environment in 2024 will largely depend on global economic development, trade policies, technology competition, human resource markets, and geopolitical risks. The catering industry is affected by factors such as changes in consumer demand, market innovation and competitor strategies. Tea and beverage companies should pay attention to consumers' health awareness and needs, continue to innovate and launch products in line with market trends, and build diversified sales channels to maintain competitiveness and sustainable development.

3. Influence of the legal environment

- ① From January 1, 2024, China has adjusted the import and export tariffs of some commodities to promote a high-level of opening-up, a domestic and international circular economy, as well as sound economic development.
- ② Announcement of the "Decision of the State Council on Amendment of the Rules for Implementation of the Patent Law of the People's Republic of China", will come into

effect on January 20, 2024. This aims to improve the patent application system, facilitate patent acquisition for applicants, strengthen patent protection, safeguard the legitimate rights and interests of patents, and encourage innovation in enterprises research and development.

- ③ On January 21, the State Taxation Administration issued a new version of the "Taxation Policy Guidelines to Stabilize Foreign Trade and Foreign Investment", updates the relevant taxation support policies and tax collection service measures currently in effect. This way, taxpayers can better understand and apply to the policies, and create a framework for the development of foreign trade and foreign investment, therefore creating a favorable tax environment for the development of foreign trade and investment.
- ① On January 22, the State Council held an executive meeting to listen to a report on the operation of the capital market and work considerations. The meeting emphasized the need to further improve the basic system of the capital market, pay more attention to the dynamic balance of investment and financing, and vigorously improve the quality of listed companies and investment value, increase the influx of mid- and long-term funds into the market, and strengthen the inherent stability of the market.

VI. Development strategies

- 1). The Company's main customers are new tea beverages and new retail businesses. To better serve these customers, the Company has mobilized experienced R&D personnel to form a dedicated R&D team for main customers. This team works closely with the marketing, sales, production, quality control, and supply chain departments to swiftly respond to customer needs. They provide exclusive formulas and packaging for customers to ensure product differentiation. Additionally, the Company is optimizing their distribution network, collaborating deeply with high-quality distributors to offer customized products that meet the diverse customer demands. Empower traditional sales channel distributors to use the fresh online ordering platform to provide distributors with customer acquisition tools and product distribution solutions, to achieve complementary advantages with distributors, multi-win-win, and jointly serve customers. The Company will also continue to expand and deepen the sales channels of coffee, baking, and Chinese cuisines in the future. The Company will be committed to expanding the sales network coverage from first- and second-tier cities to new firsttier cities and third- and fourth-tier cities in order to increase the market breadth of the products and the number of customer groups, ultimately increasing the scale of the its product and sales.
- ②. The Company will consistently adhere to a market and customer-based approach, continuously broaden its product lines and upgrade its product technology, to enhance its ability to quickly respond to customized customer needs. Furthermore, the Company will leverage AI, big data, and other analytical tools to deepen the understanding of industry trends and regional differences in the evolving new tea beverage market while

- serving customers. Combine new raw materials, new formulas, and new technologies to develop new products to meet the diversified needs of the market, leading the market trend, and enhance the core competitiveness of the Company.
- ③. In order to meet the needs of business development and improve production efficiency and timeliness of delivery, the Company has upgraded the refrigeration capacity of its three factories in Kunshan, Guangdong and Tianjin this year. Additionally, we have optimized the layout of production lines and equipment at the raw material factory in Guangxi Base, to adapt to the production and processing requirements of different products. In the future, the Company will continue to further upgrade and optimize the production lines and equipment of Factory No. 4 to deploy smarter production workshops. The Company will enhance the scale effect of production and manufacturing while ensuring product quality, better promoting the Company's business development and increase profits, and enhance the Company's competitiveness.
- 4. The Company considers human resources as the most valuable asset, and will actively promote localization, youthfulness, and professionalism of talent teams based on existing workforce. The Company will focus on cultivating internal talents and looking for professionals with relevant experience and skills to join the team and build a diverse talent team. The Company will further strengthen the corporate culture construction, improve employment mechanism, stabilize core team, and lay a solid talent foundation for the Company's development.
- ⑤. Adhering to the foundation principle of maximizing shareholder value, the Company will, when conditions permit, pursue acquisitions of other related enterprises or merge with resources within the industry. This strategy aims to achieve expansion at low cost, improve product structure and market layout, increase market shares, extend the industrial chain, and reduce operational costs.
- ⑥. Layout for overseas incremental markets, conduct market research on targeted overseas markets, and understand consumer needs, competition patterns, and regulatory requirements in the markets. Cooperate with local distribution partners and select target markets for products with potential to achieve mid- and long-term overseas market development.
- The Company plans to further strengthen its focus on the emerging retail market and develop a range of organic, healthy, nutritious, and delicious ready-to-drink products. At the same time, the Company will further optimize product structure based on existing product lines, enabling the products to be widely used in the food industry, catering channels, everyday life, entertainment, and other applicable scenarios. By capturing consumer trends, and steadily improving brand awareness and influence, the Company aims to become a leading brand in the beverages supply chain.



Each board member shall have the necessary knowledge, skill, and experience to perform their duties. To achieve the ideal goals of corporate governance, the board of directors as a whole shall have the following abilities: I. Ability to make operational judgments. II. Accounting and financial analysis ability. III. Business management ability. IV. Crisis management ability. V. Knowledge of the industry. VI. An international market perspective. VII. Leadership ability. VIII. Decision-making ability.

Current Board of the directors of the Company consists of eight directors (including three independent directors), the independent directors account for 37.5%. They have the expertise background of accounting, laws and hospitality, and one of them have the degrees of Ph.D. Candidates nomination system is adopted when electing the directors and independent directors, where the shareholders will elect the nominees from the candidates list. As of the end of 2023, the average age of the board member is 59 years old. The Company emphasized the gender equality of the board's composition; the goal is that 25% of the board members are female. (VI) Dividend Policies and Execution of the Company

1. Dividend Policies

Any current net profit of the Company should be compensated for the loss at the end of a financial year, and then 10% of the profit after being offset will be accounted as the legal reserve. Whereas the legal reserve which has approached the total assets is not subject to this limitation. Except for the specific regulations in the Articles otherwise, the Board meeting will scheme for resolution on earnings distribution, measured by the sum of the residual earnings (if there is any), plus the retained earnings of the last year, to distribute them later by the ordinary resolution of shareholders general meeting. Also, dividends and bonuses for the shareholders shall be distributed according to the shareholding ratios.

Whereas according to the Company Law of the Cayman Islands, as well as the regulations applied for stock exchange listing, 20% at least of the current net profit shall be distributed to the shareholders as dividends or bonuses, after considering various elements concerning finance, business and operations. Dividends for the shareholders will be distributed by stock as well as cash mutually, wherein the cash dividends should not be less than 30% of the total dividends.

Except for the legal reserve as described above, The Company shall account for the appropriated retained earnings by the ordinary resolution of shareholders meeting.

2. Planning for Current Dividends Distribution:

The Company passed the disposition of earnings 2023 by resolution of the Board meeting on Mar 8, 2024, which is as below: total amount of the cash dividends is NT\$223,358 thousand, and NT\$6.6 for each share; total amount of the stock dividends is NT\$0 thousand, and NT\$0 for each share. After resolving by the shareholders general meeting, the ex-dividend date is to be defined.

(VII) Planning of Current Shareholders Meeting for Influence of issuance of bonus shares upon Operational Performance as well as Earnings per Share of the Company

The Company has not prepared and published its financial forecast, and does not have situations of issuance of bonus shares distribution, thus, not applicable.

(VIII) Remuneration for Employees, Directors and Supervisors

1. Percentage or scope defined in Articles of Incorporation of the remuneration for employees and directors:

The Company should distribute the remunerations subject to the limitation of 1% at most for the employees and 2% at most for the directors according to the current profit status. Whereas the cumulative losses of the Company should be compensated first if there are any. The current profit status as above is measured by the current income before taxes, minus the income before the remunerations distributed to the employees and directors.

Remunerations for the employees are distributed by stock dividends as well as cash dividends mutually, and the targets of distribution must include the staff of any affiliated

companies who conform with the certain conditions.

2. Accounting treatment for the basis of estimate on the current remunerations for the employees, directors and supervisors, when there is a difference between the calculation as well as the actual amount of the shares distributed as the employee remunerations, and the estimation:

Estimated amount for the remunerations of employees and directors of the Company depends on the current profit status, and is measured by the percentage defined in Articles of Incorporation. If there is any material variation of the distributed amount resolved by the Board meeting, the variations will be accounted as the annual expenses. If the amount still varies after the reporting determination date, then the variation will be treated pursuant to the accounting estimation, and be adjusted into the account in the next year.

- 3. Distribution of Remunerations Resolved by Boarding Meeting:
 - (1) Remunerations are to be distributed by cash or stock for the employees, directors and supervisors. If there is any difference of the estimated annual expenses of recognition, the differences, reasons and treatment should be disclosed:

The continuous research and development, high-efficiency smart production, excellent product quality and personalized customer service allow the Company to have a good market position. The Company produces products with nearly 2,000 types of specifications annually. Its product extensiveness and comprehensive product line can meet the diverse needs of the market and provide customers with diversified choices.

(4) New products (services) for project development

With the vigorous development of the new tea industry, in order to meet the diversified needs of the new tea market and in response to the changes in consumer consumption concepts,

the Company's main product lines have been continuously enriched, from traditional fruit and vegetable juice drinks (thickened pulp), flavor beverage (thickened pulp) and jam products, granular crystal ball products and frozen fruit and vegetable juice beverages, and in the context of pursuit of individuality, healthy consumption awareness, and the rising new retail channels, the Company launched the new retail products claiming health, nutrition, safety and value in a timely manner.

The Company has always mastered the development trend of the beverage market, continued to research and develop innovation, and constantly enriched the Company's product lines to meet the diversified needs of the market and provide customers with diversified options. This year, the Company plans to develop new products, such as Tetra Pak juice, small-package juice (pulp) products, and shaped crystal balls beverages. Meanwhile, in order to meet the overseas customers' needs, the Company is also proactively preparing products that meet the needs of overseas markets.

2. Industry Overview

(1) Current Status of Development of the Industry

The business development of the company is closely related to the boom and bust of downstream new tea beverage market and catering industry. The development and trend of the company are explained as follows:

① New Tea Beverage Market

New tea beverages refer to original tea beverages that are prepared on-site, supplemented by concentrates from various extraction methods and mixed with fresh fruits or other auxiliary materials. Given the upgrading of consumption, people's consumption needs are becoming more diversified and personalized, and the products are increasing. This trend provides many development opportunities to the new tea industry. The overall market scale of China's new tea industry tends to be rising. According to the survey data of Sullivan, the market scale of China's new tea industry has increased from RMB136 billion in 2018 to RMB383.9 billion in 2023, with a compound annual growth rate by 23.1%.

For the time being, the two most common types of beverage stores in China refer to tea shops and coffee shops. As tea is a traditional beverage in China, the ready-made tea shop industry has experienced rapid development and expansion. The market scale of the readymade tea beverage stores industry grew from RMB80.5 billion in 2018 to RMB247.3 billion in 2023, with a compound annual growth rate by 25.2%. The market share of the ready-made tea shops industry increased from 59.2% in 2018 to 64.4% in 2023. With the upgrading of consumption and the increasing demand for high-quality tea, it is expected that the market scale of the ready-made tea store industry will increase to RMB538.5 billion by 2028, accounting for 63.4% of the market share of the beverage store industry in China in 2028.

In 2023, the new tea beverage industry experienced a year of "involution", including aspects such as "pricing", "product", "scenario", "experience", "marketing", "listing", and "overseas expansion", etc. However, it is precisely because of this internal competition that the industry has accelerated its standardization and normalization, promoting the mutual progress of consumption and the market.

In 2024, it is foreseeable that new tea beverage brands will continue to fiercely compete in various directions such as "second-tier", "10 thousand store plans", "sinking", and "overseas expansion". However, in these tracks, it is destined that the disruptors will advance and the conservatives will be eliminated. The new tea beverage market will also accelerate the survival of the fittest and enter a new round of reshuffling.

② Chinese catering industry

2023 was a year marked by the waning influence of the pandemic and the restoration of economic order, as well as a year of recovery for the catering industry. Despite the ups and downs throughout the year, the return to the normal rhythms of life and the pursuit of happiness were gradually coming back into people's focus. According to data released by the National Bureau of Statistics of China, the catering revenue in China was RMB 5.289 trillion in 2023, a year-on-year increase of 20.4%. Under the background of the gradual recovery of the catering industry and the dual boost from cultural confidence and supply chain capacity overflow, the trend of going global became "phenomenal" in 2023.


As urban residents value the improvement of the living level, they eat out increasingly, and the spending on food and beverages grows strongly. This trend can be attributed to the increase in disposable income and urbanization rate. Especially, the increase in urbanization rate, especially the growing middle class with strong spending power, and the increasing preference for dining out are expected to drive the development of new tea industry in China. Upgraded consumption drives diversified demands for catering services, including fine-quality and healthy food, dining environment, service quality, and other social and recreational

needs. Notably, in recent years, the market demand for China's new tea industry has also changed, as more and more types of stores are emerging to satisfy consumers' diversified needs.

At present, the catering industry in mainland China has entered the stage of steady recovery, and the overall growth level will be improved year by year and continue to improve in the long run. After years of development and market competition, the food and beverage industry in China has entered a new stage of diversity in investors, variety in business models, and growth in chain stores. The development of the food and beverage industry in China remains strong and the outlook is bright. As one of the growth engines of China's GDP, the healthy growth and the robust development of the food and beverage industry attracts many entrepreneurs and investors.

(2) Relevance of industry, middle and downstream

The Company has been deeply involved in the beverage raw material industry for many years, and with its outstanding R&D capabilities, stable product quality, perfected manufacturing system, and extensive marketing service network, the product quality, brand image and awareness of the Company's beverage raw materials continue to improve, satisfying the diverse needs of customers by providing customers customized research and development of beverage raw materials. The above, middle and lower reaches of the Company's industry are listed as follows:



A. Impact posed by the upstream segment on the Company

The Company primarily purchases fruit and vegetable juice, sugar, gels, packaging and other raw and auxiliary materials from the upstream segment. Given the large number of upstream raw material suppliers and the price offered through multiple channels, the Company does not rely on specific upstream suppliers. Therefore, the Company is not closely dependent on the upstream segment, and the change in upstream suppliers will not pose any significant impact on the Company's development.

B. Impact posed by the downstream segment on the Company

The Company sells the main and auxiliary ingredients of ready-made beverages to downstream dealers. The industries which the customers are engaged in primarily cover the new tea industry, chain restaurant industry, food industry and new retail channels, etc. The main factors critical to the customers' demand include the national economic development, level of urbanization, resident's income, resident's life quality and consumption concepts. In the next few years, China's economy will continue to grow steadily under the new normal condition, with the continuous promotion of urbanization, increasing residents' income level, increasing demand for consumption upgrading. The new tea industry will keep growing steadily so as to offer a wide market space for the Company's development.

(3) Various development trends of products

With its fresh ingredients, novel drinking technology, trendy product positioning and accurate grasp of the general trend of consumption upgrading, new tea beverage has become one of the industries with the fastest consumption growth in recent years.

The Company will link four factories production and research and development advantages, upgrade product packaging and storage technologies, implement a small quantity with diversified production and sales models continuously, at the same time, enhance the competitive advantage of large single products in the industry from the upstream source, to provide differentiated products for customers with different positioning, continue to develop new products, and to improve quality and stability of the existing products consistently, for better product competitiveness. The company's R&D department will work closely with the market and business departments to grasp the changes in market dynamics and consumer demand, and instantly grasp the fashion trends and market opportunities to continuously develop new products and new product categories, close to the needs of consumers and lead the beverage market trend and promote the industry.

(4) Market competition situation

There are many new tea beverage companies. National chain stores, regional leaders, and individual shops coexist and thrive in the competition. New tea companies at all levels have different requirements for the quality of raw materials, which makes the industry where the Company is in coexist with large-scale enterprises and small and micro enterprises. With the gradual standardization and large-scale development of new tea beverage enterprises, higher requirements will be placed on the standardization, scale, and diversification of the new tea beverage raw material suppliers. The large-scale enterprises in the industry and SMEs will withdraw from the market gradually. Due to the strong basic demand for new tea beverages, but the lower entry threshold for the industry, as well as the new influencer products are quickly copied by other beverage brands once they are launched, the homogenization competition of products in the food and beverage industry exists, which has led to serious homogenization of the products produced by some of the raw material suppliers with weaker production technology. However, with the continuous improvement of the living standards of the residents in Mainland China, the consumers' demand for differentiated beverages continues to increase, which requires the products to develop in the direction of diversification, quality and functionality. Some new leading tea beverage brands have begun to set foot in the source fruit growing business, and even deployed in the manufacturing field, resulting in increasingly fierce competition in the industry. With the demand for natural and fresh products from new tea beverage brands, as well as the requirements of cost control, some primary processing suppliers with advantages in the origin of fruit materials have begun to deploy in the new tea beverage industry to obtain value-added income. In order to better serve customers, increase the competitive advantage, and build complete industrial chains, enterprises in the industry also begin to expand upstream and downstream. The mutual permeation and integration of upstream and downstream enterprises in the industry have made the competition more fierce. On the other hand, in the case of fierce competition in the mainland China stock market, some brands have begun to layout overseas incremental markets.

With the upgrades of consumption, the market is further saturated, and the competition among brands from different level is getting fierce. The new tea beverage industry in China is growing, and only through in-depth digital insights, meeting new consumer needs, and upgrading via digital and intelligent models, new tea beverages are able to win in the competitions.

As a new tea beverrage industry raw material supplier, the company has established distributor channels and established its own branded products in various regions of China. The products have gained recognition in the industry in terms of diversification, fresh taste and quality. In the process of rapid development of the catering industry, we have established a solid cooperative relationship with many well-known chain catering companies. At present, the company is a very rich supplier of juice products in the industry, coupled with leading technology and innovation capabilities, so that the company has a place in the industry. In the face of fierce market competition, the level of competition includes products, technology applications, services and sales channels. The company continues to enhance the advantages of its products. Through the investment of rich and efficient market activities, the optimization of resources, and the active interaction with customers, strengthen Market information feedback, providing customers with overall beverage solutions and enhancing added value, in-depth service to customers' market concepts, building customer loyalty while cultivating the market development capabilities of the channel system and building competitive advantage.

4. Short, medium and long-term business development plans

(1) Short-term business development plan:

- ①In response to the changes in the new tea beverages market and consumers' demand for healthy, natural, safe, and tasty products, we began to develop and produce molded crystal balls, aseptic packaging products, Tetra Pak juice, frozen juice, fruit pulp, plant protein, Flavored Syrup, New Retailing products, brew coffee, and other products. We provide frozen, chilled, preservative-free raw juice products to meet the customer's market demand for high quality, fresh fruit flavor. Under the demand of consumers for healthy, fresh, safety and delicious products, the Company continues to gain insight into consumer demands while improving quality and carrying out product innovations solely based on market trends and consumer demands.
- ②Under the trend of rising labor costs in the manufacturing sector, labor utilization is optimized to respond to the labor demand in the off-season. At the same time, new equipment is introduced and the production processes are optimized as we continue to make improvements to layout automation and smart equipment, improve production efficiency, and create smart factories.

- With the raw material advantages of Guangxi plant, the Company invests equipment, manpower and material resources to go deep into the upstream of raw materials to provide customers with exclusive customized products based on market demand combined with product technology application and the Company's R&D strength, to improve bulk fruit products and supply chain advantages and satisfy the diverse needs of customers.
- ⑤ Applying the Company's digital systems, such as SAP, CRM, WMS, TMS, and other digitalization systems to actively improve the Company's digital management capabilities and help brand customers.
- ®Diversify sales channels, optimize business and regional distribution, improve the service ability and management level of national chain brands and regional leading brands, improve customer adhesion, and ensure long-term stable cooperation. And at the same time, deepen the sales channels to further cultivate regional markets, enhance the loyalty of the Company and regional distributors, and deepen product distribution channels through distributor resources, and broaden the channel products' coverage so the Company's products are able

to serve a broader market.

(2) Medium-term business development plan:

- ①As a raw material supplier for the new tea beverage industry, the Company maintains healthy interactions with local governments, industry associations and national competent authorities, to feedback the Company's operations status, market status and the end users' needs to provide suggestions and opinions for formulating new tea beverage standards, so that the management and quality control of new tea beverage stores will be provided with basis, and move towards standardization and formalization.
- ②Integrate warehousing and logistics, and upgrade the data and intelligence of the supply chain system. Supply chain system is the core standard for new tea beverages franchisers when selecting partners. Supply chain companies need to continuously optimize the warehouse and logistics system, to ensure their competitiveness among suppliers.
- The rise of new media such as Douyin, Little Red Booklittle, BaiduInternational, and WeChat Official Accounts has changed people's consumption habits. With the further specification of the network platform enterprise, and the continuous digitization of the food and beverage industry in mainland China, the online consumption has grown more rapidly. The company set up an e-commerce team, expand sales channels, and achieve online and offline linkage.
- With the upgrading consumption, people have increasingly higher requirements for food health. The new tea beverage industry gradually pays more attention to the healthy raw materials and environment protection of packaging, while pursuing comprehensively healthy and eco products. The Company positions the new production lines and new equipment, and researches and develops to meet the market's demands for freshness, health and deliciousness, while providing more natural and healthy products.

(3) Long-term business development plan:

- ①Focus on R&D of new tea drink ingredients to become part of the professional supply chain for the food and beverage industry. Diversify products based on channel characteristics and requirements. Establishment of forward-looking product series and production lines by introducing new technologies and knowhow and developing new products, to maintain the Company's industry leadership.
- ②Deepen the efforts with customers and the market by integrating resources from upstream to downstream, lay out diversified sales channels and providing products with integrated services in warehousing and distribution to enhance customers' satisfaction and brand reputation.
- ③Establish strategic alliances with raw materials supplies or regions to ensure control over procurement, build supply chain advantages, ensure stable source of important raw materials, stable quality and price advantage, and enhance the overall competitiveness of the company.

- The Company will consistently adhere to a market and customer-oriented approach, continuously broaden its product lines and upgrade its product technology, to enhance its ability to quickly respond to customized customer needs. Introduce international state-of-the-art equipment, technology and management software, to reduce energy consumption and intensity and create green and smart factories.
- ⑤ According to the development strategy, the company makes human resource planning, forecasts and plans the future talent demand, talent introduction and training. The Company will further strengthen its corporate culture construction, improve its employment mechanism, stabilize its core team, and lay a solid talent foundation for the Company's development.
- ©The Company will seek to acquire or merge with businesses and technology achievements related to its main business when conditions are suitable, in line with the basic principle of maximizing shareholder value. This will help integrate market resources, achieve low-cost expansion, improve product series and market layout, increase market share, extend the industrial chain, and reduce operating costs.
 - ②Actively layout overseas markets and become a part of the global supply chain.

II. Market, Production and Sales Overview

1. Market Analysis

(1) Major Production Sales Region

The company's customers are all in mainland China, and through the directly owned channels and regional distributors as product channels, the company's products are sold to the new tea beverage systems, public food and beverage providers and industrial channels in various regions of mainland China, so the current products mainly focus on sales in all regions of mainland China. As many chain brands have begun to layout overseas markets, the company will cooperate with customers to provide products in accordance with the laws and regulations of the country or region.

(2) Market Ratio

The Company serves as a raw material supplier for the comprehensive solution of new tea beverages. In the process of rapid development of the food and beverage industry in mainland China in recent years, it has established stable cooperative relations with many well-known chain food and beverage companies and deployed distributors in various regions of mainland China. Throughout China, the beverage suppliers in the food and beverage industry in Mainland China have a wide range of products and sizes. The company is mainly engaged

in the research and development, production, and sales of fruit juice, fruit powder, fruit granules. It is difficult to clearly define the market and define its peers. However, as a whole, in terms of raw material supplies for new tea beverage the company is a very rich supplier to the industry's product line. The current positioning includes three plants and one upstream raw material production base, to correspond to the customers in the North, Middle and South China market, and the three-plant collaboration is achieved, outperforming other suppliers. Coupled with the established R&D advantages and close partnership with distributors, the Company is able to maintain a strong competitive position among the peers.

(3) Market Future Supply, Demand and Growth

① Market future supply status

The number of stores and the market size of new tea beverage grew well and continuously. Therefore, more supply chain manufacturers have been attracted to join in and jointly promote the healthy and standardized development of the industry.

The Company has the experience more than two decades in the juice beverage supply market. It has witness the development of the industry from scratch, and experience the era when milk tea was still powder sold on the street to the current new tea beverage era. The Company, in addition to the high-quality raw juice and fruit source as the backing, has a wealth of product items, and a diversified product structure, and can also customize the exclusive formula according to customer needs. Close cooperation with the channel, on the other hand, as a raw material supplier for large food processing plants, in a highly competitive supply market, the company has always maintained a competitive advantage and showed a continuous growth trend. Currently, the company relies on the production advantages of the three plants, and continues to improve the research and development capacity, production capacity and supply chain advantages of the three plants to enhance the overall competitiveness.

2Market Future Demand and Growth

With its fresh ingredients, innovative beverage preparation technology, and trendy product positioning, new tea beverages have accurately grasped the general trend of consumption upgrading, making it one of the fastest recovering industries after the epidemic. With the pursuit of healthy life and the appreciation of traditional culture, new

teas combining traditional culture with modern trend elements and are warmly embraced by consumers. New teas have become a lifestyle habit for young people. The consumers of new tea drinks are mainly young people, who have a strong demand for fashion, personalization, and health, and are more receptive to tea drinks. At the same time, the new tea brand focuses on building a young and fashionable brand image, and has attracted the attention and participation of young consumers through social media and offline events, further expanding their consumer base. Females account for nearly 70% of tea consumers, and the post-90s and post-2000s generation have become the main consumers of new teas, accounting for approximately 75% of the market. According to the census data of China, the total population of the post-90s and post-2000s generations exceeds 330 million. The post-90s generation is entering a golden period of career development, while the first batch of post-2000s has already entered society. Among the new tea consumers, 44.3% have an income of RMB 5,001 to 10,000, and 29.9% of them have an income of RMB 10,001 to 15,000. They are willing to spend, generally value quality and service, are intrigued by new things, and pursue personalization, diverse, and experiential consumption. At the same time, with the upgrading of consumption, new tea drinks are also iterated continuously, developing in a healthier, more natural, and safer path. New tea brands have launched some drinks suitable for children and middle-aged and elderly people, further expanding the consumer base. The vast consumer base brings broad development space for the new tea beverage market.

(4) Competitive Foundation

OProfessional Management Team

The Company is deeply involved in the beverage raw material industry and has an experienced management team in R&D, quality assurance, marketing and sales. The Company's sales and marketing teams have extensive industry experience that can grasp market trends in time, maintain timely and efficient communication with customers, work with the Company's R&D and quality assurance teams, and actively provide customers with beverages solutions by relying on the Company's technical advantages, R&D and quality control capabilities, as they work together to rapidly promote new products to the market. The management team of the Company are all senior experts in the industry and have a profound understanding of the industry. They have been early to deploy new tea beverage supply chains, and have comprehensively planned the development strategy of the

Company with the business philosophy of integrity. The Company's team closely follows market trends and seizes market opportunities to continue to develop new products, expand new categories, stay close to market needs, lead the beverage market trend and promote industry development. The Company's advantage in highly efficient operation and management enables the Company to provide customers with comprehensive beverage solutions and increase the added value of products. It is beneficial to strengthen customer loyalty while at the same time, cultivate market development capabilities and build competitive advantages.

©Excellent Product Development and Innovation Capabilities

The Company has a specialized R&D department that has established a comprehensive R&D system. The R&D department has a solid understanding of the fresh and healthy development trends in the beverage market and focuses on the development of nutritious and healthy products. The R&D Office is equipped with advanced experimental equipment that can conduct basic research, overcome technical difficulties, reserve innovative technologies, optimize production processes and technologies, and improve product quality and diversification. This setup facilitates the efficient development and mass production of new products, driving market trends. The Company can complete the entire process from R&D creativity or responding customer demand proposal, to sample production, cost accounting, beverage application testing, rapid response testing in the pilot workshop, and marketing trial within one month. The Company's R&D team regularly visits the market and maintains close contact with customers to deepen customer cooperation and provide comprehensive solutions. At the same time, the Company can also develop new products in collaboration with various types of customers, providing tailored customized formulas to enable customers to have differentiated and competitive products in the channel.

Over the years of research and innovation, the Company has developed a robust product line, producing close to 2,000 different specifications and categories of products each year. Regarding product quality, the Company offers products with various amounts of fruit juice or pulp. In terms of taste, the Company offers popular flavors such as strawberry, mango, passion fruit, lemon, grape, and peach, as well as less common ones such as Chinese berry, mulberry, Orahmandarin, Hawthorn Berry, and Chaenomeles speciosa. The Company also offers a variety of fruit-flavored complex tastes. In the

direction of beverage upgrades, real tea, milk, fruit, sugar, and zero additives have become selling points for major brands in marketing, and they have also become preferred choice for consumers when buying beverages. At the same time, the texture granules have played a crucial role in promoting the popularity of new tea additives. The Company has upgraded its texture granules products and launched the Red Bean Pearls and shaped crystal balls. With the continuous expansion of new tea beverage channels, the Company has launched new tea beverage products suitable for new retail channels, such as Mango Pomelo Sago, Chinese berry sago, flavored lemon tea, and lime juice, with advanced technology and food safety management. The Company's extensive and comprehensive product line can meet the diverse needs of the market and provide customers with diversified choices.

In response to the needs of the rapid development of the new tea beverage market, the Company newly deployed R&D centers for key customers this year. The marketing department's proposals, customer needs and R&D implementation are connected to meet customer product needs accurately and quickly develop new products and new flavors to cater for changing consumer needs.

3 Create a Win-win Cooperation Model

The Company's current sales model primarily focuses on direct sales, with some coverage in distribution channels. Through years of strategic planning, the Company has established a relatively complete marketing network system with efficient and high-quality sales channels, and maintains close cooperative relationships with various channels. As the new tea brand becomes a chain store, the proportion of direct selling customers has exceeded 70%. For direct selling customers, the Company has established dedicated customer service teams at all three factories. These teams are capable of providing exclusive formulas and packaging based on customer requirements, ensuring product differentiation. They also offer customized sales and distribution services to guarantee the stability of product supply quality and maintain the order of customer chain operations, which helps establish long-term partnerships built on mutual trust. For distribution customers, the Company has established a comprehensive network of distributors nationwide. In the context of competition in mature markets, the Company regularly provides market information and new product training to distributors. This enables distributors to quickly introduce the Company's new products to regional markets, expanding the Company's product visibility and influence.

Customer development aspect: The Company will segment the market into different customer groups and position them according to their needs and characteristics. For example, catering enterprises, coffee system, tea beverage chain, etc., design and customize sales plans for different customer groups, and provide targeted products and services.

Market research aspect: Understand the development trends, demand characteristics, and the competitive landscape of the tea beverage market, obtain market information through methods such as market research, product studies, and data analysis; understand consumer demand and preferences for tea raw materials, and identify market opportunities and potential customers.

Pricing strategy aspect: Formulate a reasonable pricing strategy based on product costs, market demand, and competitive conditions and develop a reasonable pricing strategy that considers the balance between price and value; strive to achieve customer satisfaction while maintaining profitability for the Company. Meanwhile, according to the level, scale and positioning of customers, we will offer specific pricing and contract binding to attract and retain customers and increase our sales share.

Supply Chain Advantage, Improve Customer Loyalty

The Company is furthering the concept of lean production management, implementing office automation (OA) systems, ERP (SAP) systems, cloud warehouse management (WMS) systems, automated storage and retrieval systems (AS/RS), advanced scheduling (APS) systems, and customer relationship management (CRM) systems. The Company continues to improve and lay out automated and intelligent production lines to improve production efficiency and build an intelligent factory. The Company is able to realize production requirements of "multi-batch, small-batch, multi-variety, and multi-specification" in order to satisfy diverse customer needs. The connection between the company's WMS system and production system makes product traceability possible, as it provides end-to-end supply chain services for numerous well-known new tea beverage businesses. The Company currently has three production facilities, located in Zhaoqing, Guangdong, Kunshan, Jiangsu, and Tianjin, respectively. The recently established Baise facility in Guangxi is an upstream processing plant that specializes in producing frozen fruit puree and pulp products. The three production facilities of the Company provide customer services within their respective geographic service areas according to the designated scope

of service. This strategy can shorten the transportation distance while improving the efficiency of customer raw material delivery, and effectively reducing transportation costs. The Company's three production facilities have a unified standard production process, which ensures stable product quality. This allows the Company to serve customers located throughout the country through its nationwide sales network. This provides customers with strong supply chain support so they can expand their business throughout the country while maintaining stable product quality.

(5) Advantages, Disadvantages and Countermeasures for the Development of the Prospects

①Advantages

A. Supported by the national industrial policy to promote high-quality development of the industry

As an important pillar industry of China's national economy, the food industry undertakes the important tasks of satisfying the needs of the residents, caring for citizens' health, stabilizing employment. Pursuant to the strategic deployment of the "Outline of the National Strategy of Innovation-Driven Development" in Mainland China, the "Food Safety Law of the People's Republic of China", the "Outline of the Program for Health China 2030", and the requirements of the "14th Five-Year Development Guidelines for Technological Progress in Light Industry", in the future, the food industry in mainland China will focus on the development of food processing technology, intelligent manufacturing technology, biotechnology, and green and low-carbon technologies to build the core competitiveness of the food industry in China and achieve high-quality development of the food industry. The policies referred to above have brought good development opportunities to the industry and are helpful to its high-quality development, especially the fast growth of the scaled enterprises in the industry.

On the positive side, there are many opportunities for China's economic development. First, China has the super large-scale market with the most potential in the world. As social expectations gradually improve, high savings will gradually shift to consumption and investment. Second, macroeconomic policies will continue to provide support for economic recovery. This year, China will continue to issue RMB 1 trillion government bonds, and the effects of policies such as cutting reserve requirement ratio, reduce taxes, and fee reductions will continue to be released in Q2 and Q3. Additionally, new measures will be introduced,

with incremental and stock policies working together to effectively promote economic recovery. Third is to increase efforts to attract foreign investment and continue to optimize the business environment. Last but not least, the new round of global technological revolution and industrial reform contains new opportunities. Technology breakthroughs in big data, artificial intelligence, new energy, quantum technology, bio-manufacturing and other fields are accelerating, driving faster transformation in production and consumption. Such developments will foster industrial changes, providing a broader stage for economic development in China.

B. The state strictly controls food safety and promotes a healthy development of the industry

The Chinese government highly emphasizes the food quality and safety. In recent years, China has promulgated a series of policies, including the "Measures for Food Safety Evaluation and Evaluation," the "National Health Plan during the 14th Five-Year Plan" and the "Market Supervision Modernization Plan during the 14th Five-Year Plan" to ensure food safety and guide the healthy development of the industry. Meanwhile, the relevant authorities promulgated the "Outline Development Plan for the Green Food Industry under the 14th Five-Year Plan," aiming to expand the scale of the green food industry, improve the green agricultural standard system, and improve product quality and brand influence. In March 2023, the State Council of the PRC promulgated the "Regulations Governing Assessment and Evaluation on Food Safety Work" to strengthen local governments' fulfillment of the management responsibilities, improve their management capabilities from the field to the table, and continuously improve the level of food safety throughout the chain, and ensure the health and safety of the people.

C. The growth of residents' income and the sinking consumption area give the industry broad room for growth

According to data from the National Bureau of Statistics of China, the per capita disposable income of Chinese residents in 2023 was RMB 39,218, a nominal increase of 6.3% compared to 2022. After adjusting for price factors, the actual increase was 6.1%. The per capita disposable income of urban residents was RMB 51,821, a nominal increase of 5.1% compared to the previous year. After deducting price factors, the actual growth was 4.8%. For rural residents, the per capita disposable income was RMB 21,691, a nominal

increase of 7.7% compared to the previous year. After deducting price factors, the actual growth was 7.6%. The national median per capita disposable income was RMB 33,036, a nominal growth of 5.3% compared to the previous year. Beverage consumption is greatly influenced by people's spending power. With the continuous economic development in Mainland China, the new tea beverage market will grow at the same time. According to the data from the National Bureau of Statistics of Mainland China, in 2022, the national per capita disposable personal income was RMB\$36,883, a nominal growth over 5.0% 2021, or a real growth of 2.9% after deducting price factors, keeping pace with economic growth. In the future, China's GDP will continue to grow steadily. The increase in per capita disposable income provides an ever-expanding market demand for the beverage industry. Meanwhile, the third and fourth tier markets in mainland China are the fastest growing markets for new tea beverage. With the accelerated urbanization and industrialization, the per capita income gap between all levels of cities in mainland China is gradually narrowing, and consumer demand is converging toward the first and second tier cities. The vast sinking market brings sufficient potential growth space to the industry.

D. The diversified needs of end consumers promote the continuous expansion of the industry

The beverage market has gradually become one that's driven by consumer demand. In the context of upgraded consumption, consumers have increasing requirements for the taste, quality, health and variety of beverages. In order to cope with the upgraded consumption and meet the personalized and diversified needs of consumers, beverages are also changing to compound, nutritious and fresh beverages. In order to meet the needs of end consumers, beverage raw material manufacturers continue to ramp up innovation of technology, develop new beverage categories, enrich beverage flavors, and expand the types of beverage granules, so that the added value of beverages continues to increase, and the industry continues to expand. The domestic demand market in China continues to grow, and there is consumption potential in the sinking market of new tea beverages.

E. Overseas market effect

As the leading brands have achieved certain results overseas, the tea brands have begun to deploy their overseas market. For the time being, the overseas market is still in a state of blue ocean, and the huge demand will bring business opportunities for the new tea products overseas.

②Disadvantages and Actual Countermeasures

A. Intense competition in the industry

Upstream suppliers directly enter the terminal pipeline, and international big companies enter the beverage industry and build their own supply chain, which makes the competition between the industry increasingly fierce. Under the pressure of fierce market competition, in addition to products that need to continue to provide price competitive advantages, it is necessary to provide customers with stable and safe product quality and diversified product selection.

Countermeasures:

To keep the competitiveness of the products, the Company establishes strategic alliances with raw materials supplies or regions to ensure control over procurement, create advantages in quality, quantity and pricing and boost product competitiveness. Introduce international state-of-the-art equipment, technology and management software, to reduce energy consumption and intensity and create green and smart factories. Develop fresh and healthy products with short shelf lives, to meet the diversity of demand from customers and to establish footprint in the new retail market. Integrating resources from upstream to downstream and providing products with integrated services in warehousing and distribution to enhance customers' satisfaction and brand reputation.

B. Increase in labor costs in mainland China

With the expansion of the company's business scale, more talents will be needed in the future, and mainland China has continued to improve the economic environment in the Mainland in recent years, increasing employment opportunities in the Mainland. Many workers choose to work near home, while the development of live delivery, new media has also affected some young people's employment outlook. In order to retain the working population, enterprises have increased their wage rates. At the same time, the government of mainland China aimed at the national economic and social development to raise people's income and gradually achieve common prosperity for all.Costs continue to rise.

Countermeasures:

In response to the continuous increase in labor costs, the company has gradually improved the production process and optimized the production technology, gradually

introduced automatic and semi-automatic equipment, improved automation standards, and increased production efficiency to reduce the impact of rising labor costs on the company's operations. Based on upgrading of business scope and sales volume of the Company, distribute production capacity and orders to the three plants to realize the joint allocation of the three plants. This increases production capabilities, allows instant services to the customers in that region, reduces transportation costs. In addition, automatic inventory and e-commerce logistics combines with the Company's large network of dealers channels to create a logistics and distribution system.

In terms of R & D, timely launching high-quality and high value-added products, and diversifying talents. Organize more training, improve employee skills, commit to improving employee productivity, and continuously maintain the company's comprehensive competitiveness and improve operational efficiency. At the same time, the company cooperates with a number of labor companies to meet the demand for short-term employment. On the other hand, the company is a domestic demand industry in mainland China. Under the general trend of rising wages, the consumption power of the Chinese people will also increase, which will drive the growth momentum of related domestic demand industries. The Company's performance is expected to benefit.

C. Fluctuations of the Prices of Raw Materials

The main raw materials of the Company's products are agricultural and by-products, fruit products, primary juice, puree, fructose and sugar, as well as packaging materials, bottles and barrels. The quality and price of agricultural and by-products are affected by climate or seasonal changes. As for granulated sugar and fructose, the prices of sugar and fructose fluctuated with markets. For bottles and barrels, the environment protection and international energy affect the price for fluctuation.

Countermeasures:

The Company strengthens the ability to integrate supply chain resources, and partner with major primary juice suppliers for long term, and work with downstream brands to establish plants or exclusive raw material bases in fruit producing areas, to ensure the safety and quality of raw materials, and become the supply chain of large system customers, for opening up the closed loops of sales and production. timely attention to market conditions, accurate estimation of annual consumption, lock in annual demand in low price or mass

production season, and strive for excellent price; The company continues to maintain ample liquidity and strengthen customer credit Control and account recovery, use the capital advantage to shorten the payment account period to obtain more favorable material prices, thereby reducing the cost of raw materials, and report the raw material market conditions to the distributors or catering industry at any time to advance the access route Customers will have a price adjustment message.

D. Safety of beverage ingredients and additives

Food safety is one of the focuses of the whole society that concerns people's well-being. The Chinese government has always attached great importance to food safety and have increased crackdowns and penalties through the adoption of the "Food Safety Law of the People's Republic of China". To a certain extent, the consumption enthusiasm of the end consumers is affected, which will bring certain negative impacts to the upstream beverage industry, especially the beverage raw material manufacturers.

Countermeasures:

For the revision of relevant food safety management regulations and the promulgation of new laws and regulations, the best preparation and planning shall be carried out in advance to minimize the risk of uncertainty; Arranging quality assurance personnel to learn the latest food safety related regulations, and update the markings on products and labels in a timely manner; organizing the quality assurance and R&D personnel to sort out the Company's products and standards, to ensure that all products meet the regulatory requirements. Enhancing the appraisal and management of upstream suppliers, activating the preventive mechanism, to ensure that the qualifications and raw materials meet the regulations and the acceptance standards of the Company's internal control.

E. Severe product homogeneity

There are many small enterprises in the new tea industry. These companies have lower production technology standards and less R&D investment. They do not focus on product innovation, but imitate new products on the market, resulting in the homogenization of the products in the beverage raw material industry, resulting in the minor differences in product category, formula and taste. The product homogenization in the industry has affected the order and development of the industry.

Countermeasures:

With the continuous improvement of the living standards of the residents in Mainland China, the consumers' demand for differentiated beverages also continues to increase, which requires the products to develop in the direction of diversification, quality and functionality. The Company closely follows market demand and leads the market trend, increases the investment in R&D and production equipment, improves R&D and production capabilities, and obtains the first-mover advantage in the market through differentiated competition, improves the Company's brand awareness and enhances customer loyalty.


2. Major Purposes and Production Process of Major Products

(1) Major Purposes of Major Products



(1) Impact analysis on the company

Foreign currency exchange gains and losses accounted for a small proportion of net revenue and before-tax net profit, so exchange rate changes benefit the company It has not yet had a major impact.

The Company's operating entity is located in mainland China. Currently, the sales department is fully sold in mainland China, and is denominated in RMB. The purchase is mainly for the purchase of suppliers from mainland China or raw juice agents, and only a small portion of the raw juice is directly directed. Foreign suppliers import and are denominated in US dollars or Euros. Because the purchase ratio is not high and the amount is small, the fluctuation of RMB exchange rate against the US dollar will not cause exchange risk of the foreign currency parts of the Group.

The main functional currency of the Company is mainly RMB. As of now, there is no significant risk of exchange rate fluctuations. However, Cayman Holdings, which is listed for listing in Taiwan, will raise funds in the Republic of China and issue dividends to domestic investors. Therefore, there is a risk of exchange rate changes between the USD and the NTD.

(2) Actual Countermeasures

In order to reduce the impact of exchange rate changes on the Company's profit and loss, the Company will collect exchange rate information at any time, through the online exchange rate real-time system and strengthen the relationship with financial institutions, in order to study the trend of exchange rate changes, as a reference for settlement, in terms of strategy Balance foreign currency assets and liabilities as much as possible to achieve the effect of natural hedging and reduce the impact of exchange rate fluctuations.

3. Inflation:

(1) Impact analysis on the company

In recent years, due to the impact of global related resources and materials, the overall economic environment has shown an inflation trend, but the company has not yet had an immediate and significant impact due to inflation.

(2) Actual Countermeasures

The Company pays attention to the fluctuation of the raw material market price at any time, and maintains a good interaction with suppliers and customers, pre-judging the trend of raw materials, pre-determining the purchase volume and centralized purchasing methods to reduce the impact of price increases.

The R&D investment is mainly for the input of personnel and equipment to enhance R&D technology and strengthen natural Health product research and development, close to the customer and market demand, and enhance the overall revenue and profit of the company.

The introduction of customized SAP system improves the efficiency of enterprise information management, reduces operating costs, improves supply chain management, controls production processes, improves production efficiency, effectively controls product inventory, and maximizes management economic benefits.

In response to the increasingly serious food safety issues, The company is leading the industry in the introduction of automatic storage system (WMS), transportation Management System (TMS) ,combined with the SAP system, through the coding system, the warehouse control system (WCS) and storage hardware equipment, the two-dimensional code is used in the process of material entry and exit, with the production and sales history system as a standardized operating specification It is conducive to the rational production of the company and enhance production technology and management capabilities.

The Company pays attention to the technological changes and technological development

of the industry in its place, and quickly grasps the industry dynamics and inter-bank market information, and adopts a sound financial management strategy to maintain market competitiveness. In the future, the Company will continue to pay attention to the relevant technological changes in the industry in which it operates, and assess its impact on the company's operations, and make corresponding adjustments to strengthen the business development and financial status of the Company's business. Therefore, technological changes and industrial changes have no significant adverse impact on the Company.



INDEPENDENT AUDITORS' REPORT

The Board of Directors and Shareholders Sunjuice Holdings Co., Limited

Opinion

We have audited the accompanying consolidated financial statements of Sunjuice Holdings Co., Limited (the "Company") and its subsidiaries (collectively referred to as the "Group"), which comprise the consolidated balance sheets as of December 31, 2023 and 2022, and the consolidated statements of comprehensive income, changes in equity and cash flows for the years then ended, and notes to the consolidated financial statements, including material accounting policy information (collectively referred to as the "consolidated financial statements").

In our opinion, the accompanying consolidated financial statements present fairly, in all material respects, the consolidated financial position of the Group as of December 31, 2023 and 2022, and its consolidated financial performance and its consolidated cash flows for the years then ended in accordance with the Regulations Governing the Preparation of Financial Reports by Securities Issuers, and International Financial Reporting Standards (IFRS), International Accounting Standards (IAS), IFRIC Interpretations (IFRIC), and SIC Interpretations (SIC) endorsed and issued into effect by the Financial Supervisory Commission of the Republic of China.

Basis for Opinion

We conducted our audits in accordance with the Regulations Governing Financial Statement Audit and Attestation Engagements of Certified Public Accountants and the Standards on Auditing of the Republic of China. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Consolidated Financial Statements section of our report. We are independent of the Group in accordance with The Norm of Professional Ethics for Certified Public Accountant of the Republic of China, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the consolidated financial statements for the year ended December 31, 2023. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

The key audit matter identified in the Group's consolidated financial statements for the year ended December 31, 2023 is described as follows:

Revenue Recognition

In consideration of the materiality, auditing standards and recognition of sales revenue, which includes a presumption of significant risk, we identified the occurrence of sales revenue from specific customers as a key audit matter. Refer to Note 4(k) for the related accounting policies.

Our main audit procedures performed in respect of the above-mentioned key audit matter included the following:

- 1. We understood and tested the design and operating effectiveness of the key controls.
- 2. We sampled the details of sales revenue derived from specific customers, obtained delivery acceptance receipt signings and related information, and payment records to verify the validity of the revenue recognition.

Responsibilities of Management and Those Charged with Governance for the Consolidated Financial Statements

Management is responsible for the preparation and fair presentation of the consolidated financial statements in accordance with the Regulations Governing the Preparation of Financial Reports by Securities Issuers, and International Financial Reporting Standards (IFRS), International Accounting Standards (IAS), IFRIC Interpretations (IFRIC), and SIC Interpretations (SIC) endorsed and issued into effect by the Financial Supervisory Commission of the Republic of China, and for such internal control as management determines is necessary to enable the preparation of consolidated financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the consolidated financial statements, management is responsible for assessing the Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Group or to cease operations, or has no realistic alternative but to do so.

Those charged with governance, including the audit committee, are responsible for overseeing the Group's financial reporting process.

Auditors' Responsibilities for the Audit of the Consolidated Financial Statements

Our objectives are to obtain reasonable assurance about whether the consolidated financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the Standards on Auditing of the Republic of China will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these consolidated financial statements.

As part of an audit in accordance with the Standards on Auditing of the Republic of China, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- 1. Identify and assess the risks of material misstatement of the consolidated financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- 2. Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Group's internal control.
- 3. Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- 4. Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Group's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditors' report to the related disclosures in the consolidated financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditors' report. However, future events or conditions may cause the Group to cease to continue as a going concern.
- 5. Evaluate the overall presentation, structure and content of the consolidated financial statements, including the disclosures, and whether the consolidated financial statements represent the underlying transactions and events in a manner that achieves fair presentation.
- 6. Obtain sufficient and appropriate audit evidence regarding the financial information of entities or business activities within the Group to express an opinion on the consolidated financial statements. We are responsible for the direction, supervision, and performance of the group audit. We remain solely responsible for our audit opinion.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

From the matters communicated with those charged with governance, we determine those matters that were of most significance in the audit of the consolidated financial statements for the year ended December 31, 2023 and are therefore the key audit matters. We describe these matters in our auditors' report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

NOTES TO CONSOLIDATED FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2023 AND 2022

(In Thousands of New Taiwan Dollars, Unless Stated Otherwise)

1. GENERAL INFORMATION

Sunjuice Holdings Co., Limited (the "Company") was incorporated in the Cayman Islands in January 2010. The Company and its subsidiaries (collectively, the "Group") mainly engage in the production and wholesale of juice, fruit granules and powder.

The Company's shares were listed on the Taipei Exchange (TPEx) since September 5, 2012, and have been listed on the mainboard of the Taiwan Stock Exchange (TWSE) since March 17, 2016.

The functional currency of the Company is the Renminbi. For greater comparability and consistency of financial reporting, the consolidated financial statements are presented in the New Taiwan dollars since the Company's shares are listed on the TWSE.

2. APPROVAL OF FINANCIAL STATEMENTS

The consolidated financial statements were approved by the Company's board of directors on March 8, 2024.

3. APPLICATION OF NEW, AMENDED AND REVISED STANDARDS AND INTERPRETATIONS

a. Initial application of the amendments to the International Financial Reporting Standards (IFRS), International Accounting Standards (IAS), IFRIC Interpretations (IFRIC), and SIC Interpretations (SIC) (collectively, the "IFRS Accounting Standards") endorsed and issued into effect by the Financial Supervisory Commission (FSC)

The initial application of the IFRS Accounting Standards endorsed and issued into effect by the FSC did not have a material impact on the Group's accounting policies.

- Note 1: Unless stated otherwise, the above IFRS Accounting Standards will be effective for annual reporting periods beginning on or after their respective effective dates.

Amendments to IAS 1 "Classification of Liabilities as Current or Non-current" (referred to as the "2020 amendments") and "Non-current Liabilities with Covenants" (referred to as the "2022 amendments")

The 2020 amendments clarify that for a liability to be classified as non-current, the Group shall assess whether it has the right at the end of the reporting period to defer settlement of the liability for at least twelve months after the reporting period. If such rights exist at the end of the reporting period, the liability is classified as non-current regardless of whether the Group will exercise that right.

The 2020 amendments also stipulate that, if the right to defer settlement is subject to compliance with specified conditions, the Group must comply with those conditions at the end of the reporting period even if the lender does not test compliance until a later date. The 2022 amendments further clarify that only covenants with which an entity is required to comply on or before the reporting date should affect the classification of a liability as current or non-current. Although the covenants to be complied with within twelve months after the reporting period do not affect the classification of a liability, the Group shall disclose information that enables users of financial statements to understand the risk of the Group, which may have difficulty complying with the covenants and repaying its liabilities within twelve months after the reporting period.

The 2020 amendments stipulate that, for the purpose of liability classification, the aforementioned settlement refers to a transfer of cash, other economic resources or the Group's own equity instruments to the counterparty that results in the extinguishment of the liability. However, if the terms of a liability that, at the option of the counterparty, result in its settlement by a transfer of the Group's own equity instruments, and if such an option is recognized separately as equity in accordance with IAS 32 "Financial Instruments: Presentation", the aforementioned terms would not affect the classification of the liability.

Except for the above impact, as of the date the consolidated financial statements were authorized for issue, the Group has assessed that the application of other standards and interpretations will not have a material impact on the Group's financial position and financial performance.

- Note 1: Unless stated otherwise, the above IFRS Accounting Standards are effective for annual reporting periods beginning on or after their respective effective dates.

As of the date the consolidated financial statements were authorized for issue, the Group is continuously assessing the possible impact that the application of other standards and interpretations will have on the Group's financial position and financial performance and will disclose the relevant impact when the assessment is completed.

4. SUMMARY OF MATERIAL ACCOUNTING POLICY INFORMATION

a. Statement of compliance

The consolidated financial statements have been prepared in accordance with the Regulations Governing the Preparation of Financial Reports by Securities Issuers and IFRS Accounting Standards as endorsed and issued into effect by the FSC.

b. Basis of preparation

The consolidated financial statements have been prepared on the historical cost basis except for financial instruments which are measured at fair value.

The fair value measurements, which are grouped into Levels 1 to 3 based on the degree to which the fair value measurement inputs are observable and based on the significance of the inputs to the fair value measurement in its entirety, are described as follows:

- 1) Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities;
- 2) Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for an asset or liability, either directly (i.e., as prices) or indirectly (i.e., derived from prices); and
- 3) Level 3 inputs are unobservable inputs for an asset or liability.

c. Classification of current and non-current assets and liabilities

Current assets include:

- 1) Assets held primarily for the purpose of trading;
- 2) Assets expected to be realized within 12 months after the reporting period; and
- 3) Cash and cash equivalents unless the asset is restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period.

Current liabilities include:

- 1) Liabilities held primarily for the purpose of trading;
- 2) Liabilities due to be settled within 12 months after the reporting period; and
- 3) Liabilities for which the Group does not have an unconditional right to defer settlement for at least 12 months after the reporting period.

Assets and liabilities that are not classified as current are classified as non-current.

d. Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and the entities controlled by the Company (i.e., its subsidiaries).

Income and expenses of subsidiaries acquired or disposed of during the period are included in the consolidated statement of comprehensive income from the effective dates of acquisitions up to the effective dates of disposals, as appropriate.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with those of the Group.

All intra-group transactions, balances, income and expenses are eliminated in full upon consolidation. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

Changes in the Group's ownership interests in subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the interests of the Group and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognized directly in equity and attributed to the owners of the Company.

When the Group loses control of a subsidiary, a gain or loss is recognized in profit or loss and is calculated as the difference between (i) the aggregate of the fair value of the consideration received and any investment retained in the former subsidiary at its fair value at the date when control is lost and (ii) the assets (including any goodwill) and liabilities and any non-controlling interests of the former subsidiary at their carrying amounts at the date when control is lost. The Group accounts for all amounts recognized in other comprehensive income in relation to that subsidiary on the same basis as would be required had the Group directly disposed of the related assets or liabilities.

See Note 10, Tables 5 and 6 for detailed information on subsidiaries (including percentages of ownership and main businesses).

e. Foreign currencies

In preparing the financial statements of each individual entity in the Group, transactions in currencies other than the entity's functional currency (i.e., foreign currencies) are recognized at the rates of exchange prevailing at the dates of the transactions.

At the end of each reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Exchange differences on monetary items arising from settlement or translation are recognized in profit or loss in the period in which they arise.

Non-monetary items measured at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Exchange differences arising from the retranslation of non-monetary items are included in profit or loss for the period except for exchange differences arising from the retranslation of non-monetary items in respect of which gains and losses are recognized directly in other comprehensive income; in which cases, the exchange differences are also recognized directly in other comprehensive income.

Non-monetary items denominated in a foreign currency and measured at historical cost is stated at the reporting currency as originally translated from the foreign currency.

For the purpose of presenting the consolidated financial statements, the financial statements of the Company and its foreign operations (including subsidiaries, associates, joint ventures and branches in other countries that are prepared using functional currencies which are different from the currency of the Company) are translated into the presentation currency, the New Taiwan dollar, as follows: Assets and liabilities are translated at the exchange rates prevailing at the end of the reporting period; and income and expense items are translated at the average exchange rates for the period. The resulting currency translation differences are recognized in other comprehensive income (attributed to the owners of the Company and non-controlling interests as appropriate). The exchange differences accumulated in equity, which resulted from the translation of the assets and liabilities of the entities in the Group from functional currencies to the presentation currency, are not subsequently reclassified to profit or loss.

f. Inventories

Inventories consist of raw materials, supplies, finished goods and work in process and are stated at the lower of cost or net realizable value. Inventory write-downs are made by item, except where it may be appropriate to group similar or related items. The net realizable value is the estimated selling price of inventories less all estimated costs of completion and costs necessary to make the sale. Inventories are recorded at the weighted-average cost on the balance sheet date.

g. Property, plant and equipment

Property, plant and equipment are initially measured at cost and subsequently measured at cost less accumulated depreciation and accumulated impairment loss.

Property, plant and equipment in the course of construction are measured at cost less any recognized impairment loss. Cost includes professional fees and borrowing costs eligible for capitalization. Samples produced when testing whether an item of property, plant and equipment is functioning properly before that asset reaches its intended use are measured at the lower of cost or net realizable value, and any proceeds from selling those samples and the cost of those samples are recognized in profit or loss. Such assets are depreciated and classified to the appropriate categories of property, plant and equipment when completed and ready for their intended use.

The depreciation of property, plant and equipment is recognized using the straight-line method. Each significant part is depreciated separately. The estimated useful lives, residual values and depreciation methods are reviewed at the end of each reporting period, with the effects of any changes in the estimates accounted for on a prospective basis.

On derecognition of an item of property, plant and equipment, the difference between the sales proceeds and the carrying amount of the asset is recognized in profit or loss.

h. Intangible assets

1) Intangible assets acquired separately

Intangible assets with finite useful lives that are acquired separately are initially measured at cost and subsequently measured at cost less accumulated amortization and accumulated impairment loss. Amortization is recognized on a straight-line basis. The estimated useful lives, residual values, and amortization methods are reviewed at the end of each reporting period, with the effect of any changes in the estimates accounted for on a prospective basis. Intangible assets with indefinite useful lives that are acquired separately are measured at cost less accumulated impairment loss.

2) Derecognition of intangible assets

On derecognition of an intangible asset, the difference between the net disposal proceeds and the carrying amount of the asset is recognized in profit or loss.

i. Impairment of property, plant and equipment, right-of-use assets, intangible assets and assets related to contract costs

At the end of each reporting period, the Group reviews the carrying amounts of its property, plant and equipment and intangible assets to determine whether there is any indication that those assets have suffered any impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss. When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. Corporate assets are allocated to the individual cash-generating units on a reasonable and consistent basis of allocation.

The recoverable amount is the higher of fair value less costs to sell and value in use. If the recoverable amount of an asset or cash-generating unit is estimated to be less than its carrying amount, the carrying amount of the asset or cash-generating unit is reduced to its recoverable amount, with the resulting impairment loss recognized in profit or loss.

Before the Group recognizes an impairment loss from assets related to contract costs, any impairment loss on inventories, property, plant and equipment and intangible assets related to the contract applicable under IFRS 15 shall be recognized in accordance with applicable standards. Then, impairment loss from the assets related to the contract costs is recognized to the extent that the carrying amount of the assets exceeds the remaining amount of consideration that the Group expects to receive in exchange for related goods or services less the costs which relate directly to providing those goods or services and which have not been recognized as expenses. The assets related to the contract costs are then included in the carrying amount of the cash-generating unit to which they belong for the purpose of evaluating impairment of that cash-generating unit.

When an impairment loss is subsequently reversed, the carrying amount of the corresponding asset, cash-generating unit or assets related to contract costs is increased to the revised estimate of its recoverable amount, but only to the extent of the carrying amount that would have been determined had no impairment loss been recognized on the asset, cash-generating unit or assets related to contract costs in prior years. A reversal of an impairment loss is recognized in profit or loss.

j. Financial instruments

Financial assets and financial liabilities are recognized when the Group becomes a party to the contractual provisions of the instruments.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issuance of financial assets and financial liabilities (other than financial assets and financial liabilities at FVTPL) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognized immediately in profit or loss.

1) Financial assets

All regular way purchases or sales of financial assets are recognized and derecognized on a trade date basis.

a) Measurement categories

Financial assets are classified as financial assets at amortized cost.

Financial assets at amortized cost

Financial assets that meet the following conditions are subsequently measured at amortized cost:

- i. The financial asset is held within a business model whose objective is to hold financial assets in order to collect contractual cash flows; and
- ii. The contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Subsequent to initial recognition, financial assets at amortized cost, including cash and cash equivalents, notes receivable, trade receivables, other receivables and refundable deposits, are measured at amortized cost, which equals the gross carrying amount determined by the effective interest method less any impairment loss. Exchange differences are recognized in profit or loss.

Interest income is calculated by applying the effective interest rate to the gross carrying amount of such a financial asset, except for:

- i. Purchased or originated credit-impaired financial assets, for which interest income is calculated by applying the credit-adjusted effective interest rate to the amortized cost of such financial assets; and
- ii. Financial asset that is not credit impaired on purchase or origination but has subsequently become credit impaired, for which interest income is calculated by applying the effective interest rate to the amortized cost of such financial assets in subsequent reporting periods.

A financial asset is credit impaired when one or more of the following events have occurred:

- i. Significant financial difficulty of the issuer or the borrower;
- ii. Breach of contract, such as a default;
- iii. It is becoming probable that the borrower will enter bankruptcy or undergo a financial reorganization; or
- iv. The disappearance of an active market for that financial asset because of financial difficulties.

Cash equivalents include time deposits with original maturities within 3 months from the date of acquisition, which are highly liquid, readily convertible to a known amount of cash and are subject to an insignificant risk of changes in value. These cash equivalents are held for the purpose of meeting short-term cash commitments.

b) Impairment of financial assets and contract assets

The Group recognizes a loss allowance for expected credit losses on financial assets at amortized cost (including trade receivables), investments in debt instruments that are measured at FVTOCI, lease receivables, as well as contract assets.

The Group always recognizes lifetime expected credit loss (ECLs) for trade receivables. For all other financial instruments, the Group recognizes lifetime ECLs when there has been a significant increase in credit risk since initial recognition. If, on the other hand, the credit risk on the financial instrument has not increased significantly since initial recognition, the Group measures the loss allowance for that financial instrument at an amount equal to 12-month ECL.

Expected credit losses reflect the weighted average of credit losses with the respective risks of default occurring as the weights. Lifetime ECLs represents the expected credit losses that will result from all possible default events over the expected life of a financial instrument. In contrast, 12-month ECLs represent the portion of lifetime ECLs that is expected to result from default events on a financial instrument that are possible within 12 months after the reporting date.

The impairment loss of all financial assets is recognized in profit or loss by a reduction in their carrying amounts through a loss allowance account.

c) Derecognition of financial assets

The Group derecognizes a financial asset only when the contractual rights to the cash flows from the asset expire or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another party.

On derecognition of a financial asset at amortized cost in its entirety, the difference between the asset's carrying amount and the sum of the consideration received and receivable is recognized in profit or loss.

2) Equity instruments

Debt and equity instruments issued by the Group are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument.

Equity instruments issued by the Group are recognized at the proceeds received, net of direct issue costs.

The repurchase of the Group's own equity instruments is recognized in and deducted directly from equity, and its carrying amounts are calculated based on weighted average by share types. No gain or loss is recognized in profit or loss on the purchase, sale, issuance or cancellation of the Group's own equity instruments.

3) Financial liabilities

a) Subsequent measurement

All financial liabilities are measured at amortized cost using the effective interest method.

b) Derecognition of financial assets

The difference between the carrying amount of a financial liability derecognized and the consideration paid, including any non-cash assets transferred or liabilities assumed, is recognized in profit or loss.

k. Revenue recognition

The Group identifies contracts with customers, allocates the transaction price to the performance obligations and recognizes revenue when performance obligations are satisfied.

Revenue from the sale of goods

Revenue from the sale of goods comes from sales of juice products.

Revenue from the sale of goods comes from sales of the juice, fruit granules and powder products. Sales of products are recognized as revenue when the goods are delivered to the customer's specific location or the goods are shipped because it is the time when the customer has full discretion over the manner of distribution and price to sell the goods, has the primary responsibility for sales to future customers and bears the risks of obsolescence. Sales and trade receivables are recognized concurrently.

1. Leases

At the inception of a contract, the Group assesses whether the contract is, or contains, a lease.

For a contract that contains a lease component and non-lease components, the Group allocates the consideration in the contract to each component on the basis of the relative stand-alone price and accounts for each component separately.

The Group as lessee

The Group recognizes right-of-use assets and lease liabilities for all leases at the commencement date of a lease, except for short-term leases and low-value asset leases accounted for applying a recognition exemption where lease payments are recognized as expenses on a straight-line basis over the lease terms.

Right-of-use assets are initially measured at cost, which comprises the initial measurement of lease liabilities adjusted for lease payments made at or before the commencement date, plus any initial direct costs incurred and an estimate of costs needed to restore the underlying assets, and less any lease incentives received. Right-of-use assets are subsequently measured at cost less accumulated depreciation and impairment losses and adjusted for any remeasurement of the lease liabilities. Right-of-use assets are presented on a separate line in the consolidated balance sheets.

Right-of-use assets are depreciated using the straight-line method from the commencement dates to the earlier of the end of the useful lives of the right-of-use assets or the end of the lease terms.

Lease liabilities are initially measured at the present value of the lease payments. The lease payments are discounted using the interest rate implicit in a lease, if that rate can be readily determined. If that rate cannot be readily determined, the lessee's incremental borrowing rate will be used.

Subsequently, lease liabilities are measured at amortized cost using the effective interest method, with interest expense recognized over the lease terms. When there is a change in future lease payments resulting from a change in an index or a rate used to determine those payments, the Group remeasures the lease liabilities with a corresponding adjustment to the right-of-use-assets. However, if the carrying amount of the right-of-use assets is reduced to zero, any remaining amount of the remeasurement is recognized in profit or loss. Lease liabilities are presented on a separate line in the consolidated balance sheets.

m. Borrowing costs

Borrowing costs directly attributable to an acquisition, construction or production of qualifying assets are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalization.

Other than that which is stated above, all other borrowing costs are recognized in profit or loss in the period in which they are incurred.

n. Government grants

Government grants are not recognized until there is reasonable assurance that the Group will comply with the conditions attached to them and that the grants will be received.

Government grants related to income are recognized in other income on a systematic basis over the periods in which the Group recognizes as expenses the related costs that the grants intend to compensate. Specifically, government grants whose primary condition is that the Group should purchase, construct or otherwise acquire non-current assets are recognized as deferred revenue and transferred to profit or loss on a systematic and rational basis over the useful lives of the related assets.

Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognized in profit or loss in the period in which they are received.

o. Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

1) Current tax

Income tax payable (recoverable) is based on taxable profit (loss) for the year determined according to the applicable tax laws of each tax jurisdiction. Adjustments of prior years' tax liabilities are added to or deducted from the current year's tax provision.

2) Deferred tax

Deferred tax is recognized on temporary differences between the carrying amounts of assets and liabilities and the corresponding tax bases used in the computation of taxable profit.

Deferred tax liabilities are generally recognized for all taxable temporary differences. Deferred tax assets are generally recognized for all deductible temporary differences and unused loss carryforwards to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilized.

Deferred tax liabilities are recognized for taxable temporary differences associated with investments in subsidiaries and associates and interests in joint arrangements, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are recognized only to the extent that it is probable that there will be sufficient taxable profits against which to utilize the benefits of the temporary differences and such temporary differences are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the assets to be recovered. A previously unrecognized deferred tax asset is also reviewed at the end of each reporting period and recognized to the extent that it has become probable that future taxable profit will allow the deferred tax asset to be recovered.

Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liabilities are settled or the assets are realized, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period. The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

3) Current and deferred taxes

Current and deferred taxes are recognized in profit or loss, except when they relate to items that are recognized in other comprehensive income or directly in equity; in which case, the current and deferred taxes are also recognized in other comprehensive income or directly in equity, respectively.

5. MATERIAL ACCOUNTING JUDGMENTS AND KEY SOURCES OF ESTIMATION UNCERTAINTY

In the application of the Group's accounting policies, management is required to make judgments, estimations, and assumptions on the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimates are revised if the revisions affect only that period or in the period of the revisions and future periods if the revisions affect both current and future periods.

The credit period of sales of goods was 15-60 days. No interest was charged on trade receivables. The Group considers any change in credit quality from the initial credit date to the balance sheet date.

The Group measures the loss allowance for trade receivables at an amount equal to lifetime ECLs. The expected credit losses on trade receivables are estimated using a provision matrix prepared by reference to the past default experience of the customer and the customer's current financial position. As the Group's historical credit loss experience does not show significantly different loss patterns for different customer segments, the provision for loss allowance based on past due status is not further distinguished according to the Group's different customer base.

The Group writes off a trade receivable when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, e.g., when the debtor has been placed under liquidation, or when the trade receivables are over 365 days past due, whichever occurs earlier. For trade receivables that have been written off, the Group continues to engage in enforcement activity to attempt to recover the receivables due. Where recoveries are made, these are recognized in profit or loss.

Shareholders' dividends may be distributed by way of cash dividends and/or stock dividends, where the ratio of cash dividends distributed shall not be less than 30% of the total dividends distributed.

In January 2016, the Group received a government grant of RMB3,400 (approximately \$14,653 thousand) thousand for the construction of a manufacturing plant. The amount was recognized as deferred revenue and subsequently transferred to profit or loss over the useful life of the related asset. This policy resulted in a credit to income of \$299 thousand and \$300 thousand for the years ended December 31, 2023 and 2022, respectively.

In March 2023 and November 2023, the Group received a government grant of RMB2,000 thousand (approximately \$8,883 thousand) and RMB1,000 thousand (approximately \$4,250 thousand), respectively for the research and development of production line equipment. The government grant was for the government to encourage enterprises to purchase R&D equipment, and the grant was issued after the purchase of equipment by enterprises. The amount was recognized as deferred revenue and subsequently transferred to profit or loss over the useful life of the related assets. This policy resulted in a credit to income of \$811 thousand for the year ended December 31, 2023.

The Group obtained economic development awards and other government subsidies in the total amount of \$24,000 thousand in 2023 and talent subsidy funds and other government subsidies in the total amount of \$32,673 thousand in 2022. The government grants were recognized in other income in the consolidated statements of comprehensive income.

23. CAPITAL MANAGEMENT

The Group manages its capital to ensure that entities in the Group will be able to continue as going concerns while maximizing the return to shareholders through the optimization of the debt and equity balance.

The capital structure of the Group consists of net debt (borrowings offset by cash and cash equivalents) and equity attributable to owners of the Company (comprising issued capital, reserves, retained earnings and other equity).

The Group is not subject to any externally imposed capital requirements.

Key management personnel of the Group review the capital structure on a quarterly basis. As part of this review, the key management personnel consider the cost of capital and the risks associated with each class of capital. Based on recommendations of the key management personnel, in order to balance the overall capital structure, the Group may adjust the amount of dividends paid to shareholders, the number of new shares issued and the amount of existing debt redeemed.

Sensitivity analysis

The Group was mainly exposed to the U.S. dollar.

The risk is managed by the Group by maintaining an appropriate mix of fixed and floating rate borrowings and using interest rate swap contracts and forward interest rate contracts. Sensitivity analysis

The sensitivity analyses below were determined based on the Group's exposure to interest rates for non-derivative instruments at the end of the reporting period. For floating rate liabilities, the analysis was prepared assuming the amount of the liability outstanding at the end of the reporting period was outstanding for the whole year. A 1% increase or decrease was used when reporting interest rate risk internally to key management personnel and represents management's assessment of the reasonably possible change in interest rates.

If interest rates had been 1% higher/lower and all other variables were held constant, the Group's pre-tax profit for the years ended December 31, 2023 and 2022 would increase by \$19,229 thousand and \$14,865 thousand, respectively, which would be mainly attributable to the Group's exposure to interest rates on its variable-rate bank borrowings and deposits.

The Group's sensitivity to interest rates decreased during the current year mainly due to the decreased in variable rate debt investments.

2) Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations, resulting in a financial loss to the Group. As of the end of the reporting period, the Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure of counterparties to discharge an obligation pertain to financial assets recognized in the consolidated balance sheet.

To minimize credit risk, the management of the Group has delegated a team responsible for determining credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group reviews the recoverable amount of each trade debt at the end of the reporting period to ensure that adequate allowances are made for irrecoverable amounts. Thus, management believes the Group's credit risk was significantly reduced.

The Group's concentration of credit risk by geographical location in China, which accounted for 100% of total trade receivables as December 31, 2023 and 2022.

28. SIGNIFICANT EVENTS AFTER THE REPORTING PERIOD

In order to increase the controlling interest, simplify the shareholding structure and strengthen the control over the subsidiary, the Company's board of directors resolved to increase the shareholding of the subsidiary Sunjuice Co. Limited in February 2024. It is expected to repurchase 12.9% of the interest in Sunjuice Co. Limited held by external shareholders, with a total amount of US\$33.2 million and 46,440,001 shares. After the completion of the transaction, the Company will indirectly hold 100% of the equity of Sunjuice Co. Limited through its subsidiary.
